

I the undersigned is appointed as the Administrator of **Alliance Francaise De Bangalore**: Thimmaiah Road, Opp. UNI, Kaverappa Layout, Vasanth Nagar, Bengaluru, Karnataka – 560 052, under Sec. 27-A of Karnataka Societies Registration Act, 1960 and vide Govt. Order No: CO 49 CSR 2021 dt:19.08.2021. Later, as the Administrator of the Society has been extended from time to time.

I have taken charge as Administrator of the Society and have been performing the duties of the Administrator till date. Meanwhile, few members of the Society filed Writ Petition No:15467/2021 (GM-KSR) in Hon'ble High Court of Karnataka regarding the conduct Elections to the Executive Committee of the Society and the Hon'ble High Court has issued order dt:15.09.2022 wherein directions were issued to conduct elections "within an outer limit of six weeks from the date this order is web hosted."

As per the orders of Hon'ble High Court, in order to conduct elections to the Executive Committee of the Society, preparation of the eligible voter list is necessary. Upon scrutiny of the documents at the Society for the preparation of the list of eligible members as per clause No.1.4 of the bye-laws was not available at the Society premises.

Vide letter dt: 28.10.2022 of the Administrator, Smt. Vidya, working as Manager (Admin) at the Society was instructed to provide the certified list of eligible members and other relevant records that would help prepare the list for the conduct of Elections. She has replied vide letter dt: 31.10.2022 mentioning that the records sought by the Administrator are available as per clauses of the Society bye-laws with the General Secretary / Director – Alliance Francaise De Bangalore.

Accordingly, vide letter dt: 31.10.2022, the Director of the Society Sri Jean Christian Randrianampizafy was directed to provide the list of eligible members of the Society by the Administrator for which he replied in letter dt: 01.11.2022 has replied informing that he has neither taken charge of any records relating to the Society nor are any records transferred to him.

As per the Government mandate, it is mandatory to have submitted the AGM proceedings to the jurisdictional District Registrar, who is the competent authority of all Co-operative Societies. A Letter dt: 27.10.2022 was written to the District Registrar of Cooperative Societies seeking to provide copies of annual records submitted to their office by the said Society. In this regard, the District Registrar of Societies has provided the copies of few years of annual records submitted by Alliance Francaise De Bangalore dt: 08.11.2022, and upon examining the records, the list of eligible members of the Society as per clause 1.4 of the bye-laws of the Society has not been found as enrolled members of the Executive Committee was not placed before AGM.

Later, upon checking the computers at the said office, data of a total of 594 lifetime single and lifetime couple unsigned list of members have been saved in the said computer and this list has been provided by Smt. Vidya, working as Manager (Admin) to my possession as the Administrator of the Society and they have informed that this list was prepared during the tenure of the past Presidents of the Society.

As per the orders of Hon'ble High Court, elections will have to be conducted to Executive Committee of the Society before 6 weeks from the issue of the order, and since the certified copy of the eligible members is not available, it has been decided to finalise the list of a total of 594 lifetime single and lifetime couple members collected and as updated and saved in the computer publishing and calling for objections. This list has been announced on the notice board of the Society from 28th November, 2022. If any of the names of members of the Society has been left out in this list, they are hereby informed to contact the Administrator, Alliance Francaise De Bangalore, Thimmaiah Road, Opp. UNI, Kaverappa Layout, Vasanth Nagar, Bengaluru, Karnataka – 560 052, before dt: 15.12.2022 in person and bringing along with them, the justifiable records for being the lifetime single and lifetime couple member of the said Society. It is hereby also informed that if any member of the Society does not submit the records before dt: 15.12.2022 regarding his/her membership of the said Society, Election process for the Executive Committee would be initiated based on the currently available list of 594 members of the Society.
